Sub: Application for "In-principle approval" prior to issue and allotment of 62,99,500 Equity Shares and 8,94,000 Convertible Warrants on preferential basis under Regulation 28(1) of the SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015.

1. We D. Kothary & Co., hereby certify that the minimum issue price for the proposed preferential issue of **Magellanic Cloud Limited**, based on the pricing formula prescribed under Regulation 164 of Chapter V of SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 has been worked out at Rs. 289.61/- per share.

The relevant date for the purpose of said minimum issue price is 18th February, 2022.

[Please note that 20th February, 2022 (Sunday) being the date 30 days prior to 22nd March, 2022 (i.e., the date on which the Extra Ordinary General Meeting of the Company is being convened in terms of the Companies Act, 2013 to consider the proposed preferential issue) falls on a weekend and accordingly, the day preceding the weekend i.e. 18th February, 2022 (Friday) is being fixed as the relevant date in compliance with the Explanation to Regulation 161 of the SEBI (ICDR) Regulations.]

Note: The Equity Shares of the Company are listed on BSE Limited ("BSE") (referred to as "Stock Exchange"). The Equity Shares of the Company are frequently traded within the meaning of explanation provided in Regulation 164(5) of Chapter V of the SEBI (ICDR) Regulations and the pricing is in compliance with Regulation 164 of Chapter V of SEBI (ICDR) Regulations, 2018.

- 2. We hereby certify that the Articles of Association of **Magellanic Cloud Limited** does not provide for a method of determination which results in a floor price higher than that determined under ICDR Regulations, 2018.
- 3. The workings for arriving at such minimum issue price have been attached herewith as **Annexure VA**.
